Meeting was called to order at 6:00pm by Chairperson Brenda Carey-Mielke.

Meeting Posting

Each Town verified that the agenda had been posted as required by State Statute 19.84(1)(b).

Approval of Minutes of the Prior Meeting

Chair Brenda Carey-Mielke presented a resolution upon a motion duly made by Randy Siewert, seconded by Brenda Carey-Mielke and carried; the following resolution was unanimously adopted:

Old Business

Selling 2010 Ambulance

Chris Schultz stated the ambulance is still for sale and is listed on several online sites. He said it is being listed for \$15,000.

Audit

Mr. Schultz stated the audit will start in September. He is waiting for a confirmation on the exact date.

New Business

MAS Commissioner

Chris Schultz reported that he had been re-elected as the commissioner for MAS.

Towns Seeking MAS Coverage

Chair Brenda Carey-Mielke stated that within the Intergovernmental Agreement, Article 5.07 states the service area can be expanded to other municipalities without them joining in the Intergovernmental Agreement pursuant to a separate intergovernmental agreement. Mr. Schultz explained that there are several other ways for this to happen, specifically the municipality joining with the joiner fee or to set a contract and rate. After some discussion, it was decided to wait and see if there are any other municipalities that approach MAS for coverage and then address it at that time.

WeinerFest

Mr. Schultz explained that MAS doesn't have the full figures yet, but expect they made approximately \$18,000. Final numbers will be reported at the next meeting.

Budget

Chris Schultz reported that the largest preliminary increase in the budget will be approximately 11% to the healthcare. He also stated that the 2022 ambulance is in need of tires, which will be about \$3,500. There was also discussion about any remodeling or additions that may be needed to the building. The commissioners in attendance agreed that this is something that we need to look at sooner rather than later so the town's can plan in their future budgets and have an idea of what this would look like as well as what the costs may be.

Upon hearing no more new business, Ms. Carey Mielke adjourned the meeting at 6:27pm. The next meeting of the MAS Commission is scheduled for September 18, 2025 at 6:00pm.
