2. **Clearly mark the driveway with lath/flagging/etc.** Driveways should maintain a 4-foot distance from side and/or rear lot lines.
3. **Obtain necessary driveway permit** from the appropriate agency; **Town** (if a town road), **Oconto County Hwy Dept.** (if a county road), or **Wis DOT** (if a state/federal road).
4. **Submit this application with a detailed sketch** showing existing driveways, existing physical addresses and the distances between them, road intersections and other pertinent information; **or** attach a printout from the **Oconto County Website** with all previously mentioned information. <http://oc17maps.co.oconto.wi.us/Html5Viewer/index.html?viewer=SOLO>

If the above conditions are not met upon the county's onsite visit, the number will not be issued. Applications will then be delayed until owner provides proper documentation for issuance of a number.
